In continuation of this Office Notification No.1-293/
2006-HPU (Acad.), dated: 19.08/2006. on the subject cited above, I
am directed to inform you that the Vice Chancellor has been pleased
to approve the inspection report dated: 21/08/2006 (copy enclosed)
in terms of the provision of Ords. 38.9 & 38.10 of the First Ordinances
of H.P. University read with Statutes 16 of the First Statutes of H.P.
University pursuant to authorization given to him by the Executive
Council vide item number 38 of its meeting held on 14/2/1995 and has
further been pleased to admit your college to the privilege of
provisional affiliation ^{of this University} to run B.Ed. Course for the Academic Session
2006 - 2007, subject to fulfillment of all the
shortcomings as have been pointed out by the Inspection Committee in
its above report on or before 31st October, 2006.

In addition to above the college is required to fulfil
the following conditions:-

1. that the compliance report of the shortcomings as have been pointed
out by the Inspection Committee must reach in the University on
or before 31st. October, 2006 along with complete proposal and
inspection fee of Rs.35,000/- for consideration of grant of
extension of affiliation for the academic session 2007-2008;
2. that the Endowment fund required to be raised in the form of
FDR jointly in the name of Registrar, HPU and Chairman/Secretary
of the Society, to the tune of Rs:1,50,000/- and submitted within
fifteen days to the University;
3. that the college shall submit annual ~~xxx~~ affiliation continuation
fee of Rs:75,000/- to the University by 31st. October, 2006 for
the academic session 2006-2007;
4. that the college shall make appointment of required number of
teaching and non-teaching staff as per NCTE/UGC/University norms
through duly constituted selection committee as per rule;
5. that the college shall submit final NOC of the State Government.
6. that the College shall abide by all conditions pointed out
in NOC by the State Government / recognition order of the
NCTE and instructions issued by the NCTE/UGC/University and the
state government for smooth functioning of the college, from
time to time;
7. that the grant of affiliation is subject to condonation of delay
in submission of application for affiliation for the academic
session 2006-2007 by the Executive Council;

- 6. that the college shall appoint chartered accountants in terms of the provision Ord. 38.5-B(h) of the First Ordinances of the University;
- 9. that the college shall constitute college management committee as per rules;
- 10. that the non-compliance of any of the above conditions shall attract the action of the University as per the rules;
